CSPI is primarily funded by the 900,000 subscribers to its [Nutrition Action Healthletter](#) and individual donors. Private foundation grants make up approximately 5% to 10% of CSPI's annual revenue of \$17 million. [Nutrition Action Healthletter](#) accepts no advertising, and CSPI accepts no corporate funds or government grants.

CSPI's [audited financial statements](#) and its [IRS Form 990](#), both of which conform to Generally Accepted Accounting Principles established by the American Institute of Certified Public Accountants, are available for inspection. CSPI is governed by a volunteer board of directors operating under its [articles of incorporation](#) and [bylaws](#). CSPI also maintains a strict [conflict of interest policy](#) for its staff and [board members](#).
